additional veterinarian referrals in order to claim any covered costs and services under your Adoption Contract).

\* Should Adopter elect to have the Dog neutered by a different veterinary provider without <u>prior</u> <u>written approval</u>, Rescue will reimburse Adopter, upon receipt of a signed "Sterilization Certificate" from the veterinarian performing the surgery, the sum of **\$**\_\_\_\_\_*only.* 

ii) In reference to the subject Dog described on Page 2 of the "Bullies & Buddies Rescue Adoption Contract," the undersigned Adopter(s) acknowledge(s) that the Dog referenced in the corresponding "Bullies & Buddies Rescue Adoption Contract" is unaltered and Adopter(s) agree(s) to adopt the Dog regardless of this fact while providing Rescue with the express assurance that a "Certificate of Sterilization" for the Dog will be provided to Rescue no later than: 20 .

No other terms or conditions within the original Adoption Contract are negated, altered, modified, or otherwise changed as a result of the Adopter(s) entering into this binding, supplemental "Sterilization Addendum."

I/We have carefully read and fully understand all the provisions of this Addendum and if I/We elect not to have the foregoing reviewed by an attorney of my/our choosing prior to its execution, acknowledge that I/We have chosen to sign it freely, knowingly, and voluntarily, and without duress or persuasion by **Bullies & Buddies Rescue**, its founder(s), volunteers, representative(s), or any agent(s) acting on their behalf
